- 遵守香港及其他地區的適用法律及法規;

- 向本公司或香港股份過戶登記分處提供與其各自業務營運有關的行政、電訊、電腦、付款或其他服務的任何代理人、承包商或第三方服務供應商;
- 香港聯交所、證監會及任何其他法定監管機關 或政府部門或法例、規則或法規所規定的其他 機構;及
- 證券持有人與其進行或擬進行交易的任何人 士或機構,例如彼等的銀行、律師、會計師或 股票經紀等。

4. 個人資料的保留
